Budget Submission Conversations

Several PIC members spoke to the group about the issues they would like included in the PIC submission. They included a plea from Jennifer Kehoe (Molly Brant) to maintain staffing levels in the classroom – both teaching and support staff – and if any savings found, to increase staffing if at possible. Hillary Wollis (LCVI) echoed this sentiment and included information to try and find efficiencies by working with partner organizations like Public Health and the City of Kingston. Courtney Bush (Winston) brought forward the idea of ensuring that both staffing and special education were priorities in the budget – this was echoed by almost everyone else in the room. Other ideas from unidentified sources including ensuring equity in schools that have students attend Challenge or LEAP and securing Gould Lake and other experiential opportunities for students. Finally, Christine Innocent (Ecole Sir John A) provided a comprehensive list of budget considerations – these were forwarded to her local Trustee as well.

Budget Submission to Trustee Elliott

Dear Trustee Elliott,

Last night, the Parent Involvement Committee discussed many opportunities for the Limestone District School Board's budget for the upcoming fiscal year. The following were determined as budget priorities by Parent Involvement Committee members:

- 1. Maintain or increase staffing levels in schools
- 2. If cost savings must be achieved, ensure they are as far away from the classroom as possible. In other words, students should not see the direct impact of these cost savings in their day to day lives at school.
- 3. Maintain experiential programs (for example Gould Lake, Focus Programs, SHSM, etc.)
- 4. Look at the transportation budget for efficiencies. Work with the City of Kingston to enable urban high school students to use city buses as much as possible instead of school buses. Have more efficient routes available for for the school arrival and departure times,
 - o Investigate at actual student school bus utilization vs those entitled to school bus use.
 - Examine the monopoly contract with Triboard.
- 5. Factor in the utilization of "Rainy Day Funds" into budget.
- 6. Scrutinize the expenditures on consultants and contractors. Referencing #2, these are the furthest away from students. Efficiencies can definitely be found in these costs.

We ask that serious consideration is given to this list during the budgeting process. Should you have any questions or require clarification, please do not hesitate to contact me.

Focus Group Discussions – Elementary & Secondary

The entire PIC group identified that they, as a group, are very concerned about the cuts to education announced by the provincial government and the unknown effects at the time of the meeting on Limestone Schools.

The purpose of this focus group discussion was to brainstorm concerns at the elementary and secondary panels due to the cuts and then propose some actions PIC could undertake. However, without specific information on how the cuts will impact Limestone, which were not readily available due to the Ministry's timelines, it was difficult to formulate any actions at the meeting.

Secondary School Group Concerns:

- physical classroom space new school won't be able to accommodate more students as square footage is a significantly less
- class ratios different between high schools and courses they offer
 - schools with ESL, School to Community, shops, etc. will need to maintain the lower ratios for these classes, leading to other classes, with already larger classes sizes getting larger
- maintaining professional supports
- summer school being all e-learning
- funds for students applying to post-secondary

Possible solutions/suggestions:

- collaboration between schools to offer courses in clusters so students could go to another school for half a day or a semester
 - KSS andLCVI, Bayridge and Frontenac students can go between campuses via Kingston transit
- creative solutions with course offerings
 - webinar style learning if a course is offered at one LDSB school but not others, students could dial into a platform such as gotomeeting and be able to hear the teacher and see their slides. Could also have a live feed from the school with the teacher so students can watch and participate online.
- the Ministry needs to give LDSB flexibility in how they can allocate funds
- provide teachers with more training if there are cuts to professional supports
- schools/the board need to be creative with space utilization
 - o areas for revenue generation need to be examined
 - o can increase accessibility for students if services on site ie dentist, doctor, etc.
