

# Positive COVID-19 Case in LCVI

## A Positive Case of COVID-19 has been identified in your school

Dear Families,

The purpose of this letter is to inform you that KFL&A Public Health has been notified that **a staff member at Loyalist Collegiate & Vocational Institute (LCVI) has tested positive for COVID-19.** Please note that if you are receiving this letter only, the positive COVID-19 case was **NOT** identified in your student's cohort.

We recognize that receiving this information may be stressful and we want to ensure you understand the process going forward. KFL&A Public Health and the school are taking all necessary steps to prevent further spread of the virus both in the school and the community.

KFL&A Public Health is working with the school to identify cohorts of students and staff who may have been in close contact with the COVID-19 positive person at school or during school transportation, if applicable.

### What should you do?

- If your student has symptoms of COVID-19, they should be tested as soon as possible. When you arrive for your student's appointment, ask the registration person to use investigation # **2241-2021-38992**.
- It is **not** necessary to have your student tested at this time if they do **not** have symptoms of COVID-19. **Testing now may lead to unnecessary or repeat testing.**
- If you receive an additional letter or are contacted by KFL&A Public Health, follow the guidance provided.
- If anyone in your household has or develops symptoms of COVID-19, they must self-isolate and should book an appointment at an assessment centre for testing as soon as possible. It is required that all household members isolate until the person with symptoms receives a negative COVID-19 test result or an alternative diagnosis from a health care professional.

### What will KFL&A Public Health do?

- Public Health Nurses will contact individuals who test positive for COVID-19 and will be in contact with the school.\*
- KFL&A Public Health will identify and contact all individuals (including students and staff) who had close contact with the person who tested positive.\*

- KFL&A Public Health will provide direction to close contacts and the school to protect students and staff and prevent the spread of COVID-19.

**What will the school do?**

- The school will provide KFL&A Public Health with contact information for identified individuals.
- The school will clean and disinfect all areas in the school where the exposure may have occurred.
- The school will work with KFL&A Public Health to develop a plan to protect all students and staff and prevent the spread of COVID-19.
