### **Purpose**

To provide the Board of Trustees with information on the 2019-2020 Director's Annual Report.

### **Background**

In compliance with the *Education Act*, the Limestone District School Board's 2019-2020 Director's Annual Report includes information on the Board's strategic goals and progress the Board has made against these goals in the previous year; and actions the Board is taking in those strategic priority areas where goals are not being met.

### **Current Status**

In keeping with the requirements under the *Education Act*, the Director of Education must report annually on the board's multi-year strategic plan via the Director's Annual Report. In Limestone, typically the Director provides progress on the Board's strategic goals and actions twice a year, through a mid-year report in May and a year-end report in November. This year, due to the COVID-19 extended school closure, only a year-end report was presented to Trustees in November 2020.

The Strategic Plan Year-End Report is provided within the online Director's Annual Report along with stories from the 2019-2020 school year that highlight some of the initiatives supporting the Board's strategic pillars of Wellness, Innovation and Collaboration.
