Multi-Year Accessibility Plan Update 2023-2026

The LDSB multi-Year Accessibility Plan is developed in accordance with the Integrated Accessibility Standards Regulation under the Accessibility for Ontarians with Disabilities Act, 2005 (AODA). It incorporates the intentions of the Board to meet its obligations under the Ontarians with Disabilities Act, 2005. The Accessibility Plan describes the measure that the Board will take over the 3-year period from January 1, 2023, to December 31, 2026, to identify, remove, and prevent barriers to people with disabilities who work, learn, and participate in the School Board community and environment including students, staff, parents and caregivers, volunteers, and visitors to the Board and its schools.

The Limestone District School Board is committed to the continual improvement of access to school board facilities, policies, programs, practices, and services for people with disabilities. The plan is guided by the Board's Accessibility Standards-Policy Statement Board's Accessibility Standards-Policy Statement as well as the Board's Mission, Vision and Values.

The LDSB Accessibility Planning Committee has been busy adjusting the multi-Year plan during the 2022-23 school year. The draft Multi-Year Accessibility Plan 2023-2026 will be brought to February's SEAC meeting for feedback and discussion. There are also plans to consult with staff, students and the community agencies through social media and the website. Finally, any details related to the plan that are referenced in the Special Education Review will be brought to the Committee's attention as well.

Clinical Community Collaboration Sessions

Clinical staff have organized three recent community collaboration sessions to share information about services/supports for students within our Board and the broader community. Previous sessions were held with the Autism Resource Hub and DDCP. <u>Professional Learning PA Day</u>



Special Education Review

As previously reported, Educational Services leadership is supporting the system in conducting a Special Education Review beginning February 27, 2023. Information was shared with Principals on February 1 and Trustees on February 8, 2023.

The purpose of the Special Education Review is to examine our current special education supports and services and identify areas for refinement and enhancement to meet the needs of all learners within an inclusive learning environment. We will complete this goal by gathering student, family, staff, and community partner voices to assist in identifying priorities and key areas which may impact the success of students with special education needs.

We will be using Thought Exchange to gather feedback. Thought Exchange allows individuals to respond to a question, then interact with other responses, in an attempt to organize the most prevalent thoughts together. The question we will be asking is as follows:

What key supports and services are important for students with special education needs to experience success at school and reach their full potential?

The Review will begin the week of February 27, 2023, for students with special education needs and their families. Later, in April, we will ask the same question of Limestone staff and Community Members/Partners. Students will respond to the questions within the school setting and will be supported by staff when necessary. We envision this being accomplished in classrooms, small groups, or individually as required. Families will also be asked to complete the question during this week. An exchange link with QR code will be sent out to families. Schools have been directed to work with families on ensuring they can access the Thought Exchange, and examples have been provided to school staff in order to support the completion of this work. Finally, all staff and community partners will be provided with the link/QR code via the LDSB website and social media. Information will be analyzed during the Spring of 2023 and a report provided to the Board and public in the fall of 2023.

Re: Special Incidence Portion Claim Funding

The Special Education Advisory Committee (SEAC) of the Near North District School Board would like to send this letter of support for the concerns expressed by the Durham District School Board regarding funding of the Special Incidence Portion (SIP)

Like other school boards in Ontario would like to remind you that in the spring of 2018 the previous government announced an increase to the SIP claim funding of \$11,016.00, bringing that funding amount up to \$38,016.00 per student from the previous funding amount of \$27,000.00. On August 24, 2018, after school board budgets were prepared and approved, the Ministry announced that the previously-announced increase would be clawed back. Currently the funding received from the Ministry is \$28,803.00, bringing the net increase to \$1,803.00 per student.

SEACs across the province were dismayed by the Ministry of Education decision to claw back that increase, given that the true costs of supporting a student with a SIP claim are significantly higher than the allocated amount. For example, the average cost, including salary and benefits, for an Educational Assistant at the Near North District School Board is \$52,397 A student who requires 2 plus Educational Assistants to support their learning needs would be at a cost of \$104,794 plus.

In the 2021-2022 school year alone, the NNDSB allocated \$707,634 more than was given in Special Education Grants to Special Education services. Some of the revenue the NNDSB has used to fund this gap is the Local Priorities Funding, which, as you are aware, is not guaranteed annual funding from the Province.

Furthermore, when you take into account the claw-back of the SIP funding increase in 2018, combined with the reallocation of the Special Education Per Pupil Amount, this resulted in a net **decrease** in funding and a further increase in the NNDSB's Special Education deficit. In 2017, the Auditor General highlighted that the Ministry of Education's "[f]unding formula uses out-of-date benchmarks and is due for a comprehensive external review."

Specifically, we urge the Minister to consider:

- A minimum 5% increase in the Special Education funding that will better align with the true costs associated with SIP claims to support our students and increase funding accordingly.
- That the Special Education funding model be reviewed annually and changed to accurately reflect the increasing and more complex needs of students with special needs.
- An improved process that will eliminate the need for such intensive applications or provide support for Boards to complete the SIP applications. It takes countless staff hours per SIP application, which impacts the time our trained Special Education teachers and leads are away from their other important work supporting high-needs students.

B. Educational Services Update:

Transition to Kindergarten (T2K)

The Transition to Kindergarten (T2K) Protocol, a joint document with other school boards and community agencies that support young children, was recently updated in February 2023. This process highlights timelines and supports that are available through the school board and community agencies as families begin to plan for entry into Kindergarten. Highlighting the process and community collaboration is the T2K Parent and Family Workshop that took place virtually on Wednesday, March 1, 2023. This workshop was attended by parents and caregivers across the district and was supported by Educational Services staff as well as community partners including KidsInclusive, KFL& A Public Health (Early Expressions), Maltby, Community Living, and our partners from the Algonquin Lakeshore Catholic District School Board. Attending this meeting were also representatives from neighbouring boards (Hastings/Prince Edward, Upper Canada and CDSBEO) who are working to replicate this event in their areas.
